RESOLUTION TO REGISTER AND REGULATE TRANSIENT VENDOR'S WITHIN THE UNINCORPORATED AREA OF BEAVER TOWNSHIP

BE IT RESOLVES BY THE BOARD OF TRUSTEES OF BEAVER TOWNSHIP, MAHONING COUNTY, OHIO, THAT IN COMPLIANCE WITH THE ENACTMENT OF AMENDED HOUSE BILL NO. 318, OF THE OHIO REVISED CODE, 505.94, GENERAL ASSEMBLY OF THE STATE OF OHIO AND EFFECTIVE JUNE 27, 1990, ALL TRANSIENT VENDOR'S AS SO DEFINED IN SECTION 505.94 OPERATING WITHIN THE TERRITORY OF THE TOWNSHIP SHALL REGISTER WITH THE TOWNSHIP AT THE TOWNSHIP ZONING OFFICE, 11999 SOUTH AVENUE, NORTH LIMA, OHIO 44452, AND ADHERE TO THE REGULATIONS SET FORTH IN THIS RESOLUTION BY THE BOARD OF TRUSTEES.

PASSED AND APPROVED THE 15TH DAY OF NOVEMBER 1990, BY THE BOARD OF TRUSTEES OF BEAVER TOWNSHIP, MAHONING COUNTY, OHIO.

AS DEFINED IN SECTION 505.94 OHIO REVISED CODE, "TRANSIENT VENDOR'S" MEANS ANY PERSON WHO OPENS A TEMPORARY PLACE OF BUSINESS FOR THE SALE OF GOODS OR WHO, ON THE STREETS OR WHILE TRAVELING ABOUT THE TOWNSHIP, SELLS, OFFERS FOR SALE, OR SOLICITS ORDERS FOR FUTURE DELIVERY OF GOODS WHERE PAYMENT IS REQUIRED PRIOR TO THE DELIVERY OF GOODS, EXCEPT THAT "TRANSIENT VENDOR" DOES NOT INCLUDE ANY PERSON WHO REPRESENTS A BUSINESS OR ORGANIZATION, INCLUDING, BUT NOT LIMITED TO, ANY ENTITY EXEMPTED FROM TAXATION UNDER SECTION 5709.04 OF THE REVISED CODE, THAT NOTIFIES THE BOARD OF TOWNSHIP TRUSTEES THAT ITS REPRESENTATIVES ARE PRESENT IN THE TOWNSHIP FOR THE PURPOSE OF SELLING, OFFERING FOR SALE, OR SOLICITING ORDERS FOR FUTURE DELIVERY OF GOODS, OR AN AUCTION OR AN AUCTIONEER COMPANY LICENSED UNDER CHAPTER 4707 OF THE REVISED CODE.

ALL TRANSIENT VENDOR'S CANVASSING DOOR-TO-DOOR WITHIN THE TOWNSHIP SHALL CONDUCT THEIR BUSINESS ACTIVITIES ONLY DURING DAYLIGHT HOURS AND NO SUNDAY SALES.

TRANSIENT VENDORS LICENSE APPLICANT

PLEASE BE INFORMED:

THE LICENSE CAN BE REVOKED FOR ANY OF THE FOLLOWING REASONS:

1. FRAUD OR MISREPRESENTATION CONTAINED IN THE REGISTRATION.
2. FRAUD, MISREPRESENTATION OR FALSE STATEMENTS MADE IN THE COURSE OF CONDUCTING THE ACTIVITY.
3. VIOLATION OF ANY OF THE PROVISIONS OF THE LAWS OF THE STATE OF OHIO OR FEDERAL LAW.
4. CONDUCTING THE BUSINESS IN AN UNLAWFUL MANNER OR IN SUCH A MANNER AS TO CONSTITUTE A MENACE TO THE HEALTH, SAFETY, OR GENERAL WELFARE OF THE PUBLIC.
5. THE PERMITTEE CEASES TO POSSESS THE QUALIFICATIONS AND CHARACTER REQUIRED IN THIS CHAPTER FOR THE ORIGINAL REGISTRATION.
6. TIME LIMITATIONS-NO DOOR-TO-DOOR BUSINESS CONDUCTED ON SUNDAY. OTHER BUSINESS HOURS WILL BE FROM 9:00 A.M. TILL DUSK UNLESS OTHERWISE STATED ON ISSUED PERMIT.
7. EACH PERMITTEE SHALL AT ALL TIMES WHILE PEDDLING OR HAWKING IN BEAVER TOWNSHIP INCIDENT TO REQUEST OR INVITATION CARRY UPON HIS PERMIT AND THE SAME SHALL BE EXHIBITED BY SUCH PERMITTEE WHENEVER HE IS REQUESTED TO DO SO BY ANY POLICE OFFICER OR BY ANY PERSON SOLICITED.
